

# Notice of Cancellation

You may cancel this transaction, without any penalty or obligation, within three business days from the above date. (Saturdays, Sundays and holidays are not business days.)

If you cancel, any property traded in, any payments made by you under the contract or sale, and any negotiable instruments executed by you will be returned within 10 business days following receipt by the seller of your cancellation notice, and any security interests arising out of the transaction will be cancelled.

If you cancel, you must make available to the seller at your residence, in substantially as good condition as when received, any goods delivered to you under this contract or sale; or you may, if you wish, comply with the instructions of the seller regarding the return shipment of the goods at the seller's expense and risk.

If you do make the goods available to the seller and the seller does not pick them up within 20 day of the date of your notice of cancellation, you may retain or dispose of the goods without any further obligation.

**Tuition:** Tuition must be paid in full by the first day of class and the student must pay 50% on registration to be accepted.

### Refund Policy:

Full Refund: The student is entitled to a full refund to be paid in 10 working days if the student cancels enrollment within 3 business days of acceptance of enrollment.

Partial Refund: A student who withdraws or is dismissed after attending at least one class or submitting at least one lesson, but before completing 60% of the potential units of instruction in the current enrollment period, shall be entitled to a pro rated refund less any amounts owed by the student for the current enrollment period, less a one time application fee of \$50.00.

No refund is awarded to students who withdraw after completing 60% of potential class units.

Notice of Withdraw. Written notice of withdrawing is recommended but not required. Prorated refunds will be paid from the last class attended less the \$50.00 application fee. It will be assumed the student withdraws after two consecutive missed classes.
